Renter Agrees to pay \$15.00 per foot for each item stored. Total amount due when item is placed in storage and payments cover from dates listed below.

LENGTH OF EQUIPMENT: Equipment length includes the entire length of the item. If any trailer is used to store item, the trailer length from the hitch to the end of the trailer will be measured.

DATE EQUIPMENT BROUGHT IN FOR STORAGE: _____

Item listed above will be stored at the Gogebic County Fair Grounds and will not be removed until the pickup date below. Items must remain and under no circumstances will be allowed to be removed from the building prior to the date below.

PICK UP DATE FOR ALL STORAGE ITEMS: APPROXIMATE DATE IS May 2nd.

All stored items must be removed from the fairgrounds building by the date agreed. The renter, or person(s) acting on the renters behalf MUST present this renters agreement contract in order to remove the stored item.

LOSS OR DAMAGES: Renter agrees that the Friends of the Fair, Inc., Gogebic County, its Board, agents and employees shall not be liable or responsible for any damage to Renter's item while stored at the Gogebic County Fairgrounds. The Renter agrees to not hold the Friends of the Fair, Inc. responsible for any items lost or stolen for the duration of the time the item is stored. Renter agrees, as a condition of this agreement, to carry property damage insurance coverage for all of the Renter's item and/or items for the duration of the time it is stored at the fairgrounds. *Renter MUST provide proof of insurance on the item(s) placed in storage.*

Renter agrees to pay the Friends of the Fair, Inc. for any or all damages to the Fairgrounds property by the renter for his/her equipment. Renter agrees to defend, indemnify, and hold harmless the Friends of the Fair, Inc., Gogebic County Fair and Gogebic County from any claim, demand, suit, loss, cost of expense, or damage which may be asserted, claimed, or recovered against or from the Gogebic County Fair, Friends of the Fair, Inc., or Gogebic County by reason of any damage to property, personal injury, or bodily injury, including death, sustained by any person whomsoever and which damage, injury or death arises out of, or is incident to or in any way connected with the performance of this agreement.
